



QLIK® WEB CONNECTORS ADDENDUM

IMPORTANT: DO NOT USE THIS SOFTWARE UNTIL YOU HAVE READ AND AGREED TO THE TERMS OF THIS ADDENDUM. BY CLICKING ON THE “I AGREE” BUTTON OR ACTIVATING OR OTHERWISE USING THE QLIK WEB CONNECTORS (THE “CONNECTORS”), YOU OR THE ENTITY THAT YOU REPRESENT (“LICENSEE”), ARE UNCONDITIONALLY CONSENTING TO BE BOUND BY AND TO BECOME A PARTY TO THIS ADDENDUM. IF LICENSEE DOES NOT UNCONDITIONALLY AGREE TO THE FOREGOING OR IF LICENSEE IS NOT AUTHORIZED TO ACCEPT THE TERMS AND CONDITIONS OF THIS ADDENDUM, DO NOT CLICK THE “I AGREE” BUTTON AND DISCONTINUE THE ACTIVATION PROCESS.

1. Subscription

1.1 Terms. The Connectors are provided on a subscription basis and may only be used with software licensed by Qlik (“Qlik Software”). Use of the Connectors is subject to and governed by the terms and conditions in the applicable Qlik Software License Agreement (“Agreement”) and this Qlik Web Connectors Addendum (“Addendum”). Subject to Licensee’s compliance with the terms of the Agreement and Addendum, Licensee is granted a limited, non-exclusive, non-transferable, revocable right to access and use the Connectors for the subscription period and licensed quantity set forth in an applicable Order Form. Licensee’s subscription for the Connectors will automatically renew at the end of each subscription period, unless Licensee provides Qlik with prior written notice of non-renewal at least thirty (30) days prior to the end of such subscription period.

1.2 In the event of a conflict between the terms and conditions in this Addendum and the Agreement, the terms and conditions in this Addendum shall take precedence, but only to the extent of the conflict. Any capitalized term not defined herein shall have the same meaning ascribed to such term in the Agreement.

1.3 Restrictions. Except as expressly permitted in the Agreement and Addendum, Licensee will not, nor will it permit or authorize anyone to (a) distribute, convey, lend, lease, share, copy, sell, charge for the right to use, transfer, market, sublicense, rent or otherwise make available the Connectors to any third party, including any Connector created with the software development kit; or (b) use the Connectors for the purpose of monitoring availability, functionality or performance for benchmarking or competitive purposes. For clarity, these restrictions are in addition to any prohibitions or restrictions applicable set forth in the Agreement. Licensee shall not disclose or provide any Software license keys or any other credentials used to access any Connectors to any user that is not an Authorized User of Licensee or an Affiliate. Licensee hereby agrees that it shall be responsible for all acts and omissions of any user to whom Licensee provides any software license keys and/or any Qlik credentials

2. Support Services

Support services are included with any paid Connector subscription and shall be provided in accordance with the

terms of the applicable maintenance and support policy for the Qlik Software.

3. Access to Third Party Sites

Licensee acknowledges that use of the Connectors to access web-based applications or services may be governed by third party terms and conditions. Licensee agrees it is solely responsible to comply with such third party terms and that Qlik shall have no liability for any claims relating to third party web-based applications, services or data sources. Qlik may terminate this Addendum upon written notice, if and only to the extent reasonably necessary to comply with any third party restrictions. Licensee further acknowledges that Qlik has no control over any third party application programming interface (“API”) or any third party data which may be used in conjunction with the Connectors. Licensee agrees Qlik shall have no liability for the Connectors if any third party APIs are changed or discontinued by the respective third parties. Licensee shall promptly apply any updates to the Connectors, which are made available from time to time.

4. Term and Termination

This Addendum and the Licensee’s subscription to the Connectors shall remain in effect until the earlier of the (a) termination or expiration of the Agreement or (b) expiration of the subscription term set forth in the applicable Order Form.

5. Standard Connectors

Certain Connectors may be made available to Licensee without a subscription fee (“Standard Connectors”). STANDARD CONNECTORS ARE PROVIDED WITHOUT WARRANTY OF ANY KIND AND QLIK DISCLAIMS ANY AND ALL EXPRESS OR IMPLIED WARRANTIES TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, INCLUDING ANY WARRANTY THAT USE OF THE CONNECTOR WILL BE UNINTERRUPTED OR ERROR FREE. Notwithstanding any provision in this Addendum or the Agreement, Qlik reserves the right at any time to add, remove, discontinue or alter the content, availability and other characteristics of the Standard Connectors without any further obligation or liability.
